An Exciting New Chapter for the Hastings Public Schools Foundation

The Hastings Public Schools Foundation announces the transition of its over \$2 million endowed fund to St. Croix Valley Foundation (SCVF), effective May 2023. This announcement marks an exciting new era for Hastings Public Schools and our students.

What Does This Change Mean for You?

HPSF is taking the next step in its mission to protect and continue building the educator grant legacy by transferring its endowed funds to SCVF. With the District 200 Administrative Team, SCVF will oversee the SPARK grants (formerly known as the What If grants), which will continue to solely support District 200 educator and staff grants through an annual distribution of endowment income, currently \$75,000.

Payroll Deduction Program Continues

For all of you who have supported the Hastings Public Schools Foundation through your payroll deductions, you will be able to continue to do so with payroll deductions to the St. Croix Valley Foundation, which will be used solely to support District 200 SPARK grants.

I authorize Independent School District 200 ("ISD 200") to deduct the amount selected below from each of my paychecks and direct ISD 200 to remit my payroll deduction amount, as soon as administratively practicable, to the Hastings Public Schools Foundation, a nonprofit 501(c)(3) corporation ("HPSF"). This agreement remains in effect until I revoke or modify it. I may revoke or modify my payroll deduction as of any day. However, to revoke or modify my payroll deduction, I must provide the ISD 200 Payroll Department at least 30 days advance written notice of my revocation or modification, specifying the effective date of the revocation or modification. By signing this agreement, I authorize ISD 200 to share my name, address, and donation amount with St. Croix Valley Foundation. St. Croix Valley Foundation does not disclose donation amounts to anyone other than its accounting staff. Your St. Croix Valley Foundation payroll deduction contributions are tax deductible. Annual gift acknowledgments will be provided by St. Croix Valley Foundation for tax purposes.
