

Hastings Public Schools Parent & Student Device User Agreement

- I will not loan my district issued device (Chromebook or iPad) out to other individuals, will not leave my device unattended, and will know where my device is at all times.
- I will bring my device to school each day, fully charged.
- I will keep food and beverages away from my device since they may cause damage to the device.
- I will not disassemble any part of the device or attempt any repairs.
- I will protect my device by keeping it in the case provided at all times (iPads only).
- I will use my device in ways that are appropriate and meet all district expectations.
- I will not place decorations (such as stickers, markers, paint, etc.) on the device or accessories. I will not deface the serial number or asset tag barcode sticker.
- I understand that the device is subject to inspection at any time without notice and remains the property of Hastings Public Schools.
- I agree to return my device promptly upon request or when withdrawing from Hastings Public Schools. I understand that if I fail to return the device and accessories (case, charger) upon request or upon termination of enrollment in Hastings Public Schools, I may be billed for the cost to replace items not returned. Failure to comply with this requirement may result in a theft report being filed with the police department.
- I agree to report any damage, loss or theft of the device to the school within 24 hours or as soon as possible.
- I understand that I have the option to purchase the Optional Protection Plan for the device. If I choose to not purchase the protection plan, I understand that I will be responsible to pay for damage or replacement of the device.
